Town Hall News

Intradistrict Budget Meeting September 17, 6:30 p.m. at the Turners Fall High School

The Selectboard has requested a special issue of the Newsletter to get out the word about the intradistrict budget meeting on September 17. As most of you know, the towns of Montague and Gill and the Gill Montague Regional School District School Committee have not yet settled on a budget for the school for the current fiscal year. This is the same situation we were in last fall and we are heading for an intradistrict meeting at the high school the same way we did last fall.

The difference is, there is no way the town can possibly meet the request from the school this year. After last year's intradistrict meeting, the town faced a small deficit. You may recall we had scheduled an override vote for February of 2008 in order to close the budget gap, but cancelled it at the last minute when we heard from the Department of Revenue that the increase in our new growth number for FY08 would save the day. We can't count on that again this year.

This year, if the school district were to receive its full request, the town faces a \$320,000 deficit. Knowing that residents cannot afford an override of that magnitude, the Selectboard is bracing for potential budget cuts. It has instituted a spending freeze on all discretionary spending until the budget with the school is settled. Departments have been told not to fill any vacant positions, not to run vehicles unnecessarily, to consolidate forty hours of staff time into four days per week to save on building energy costs, etc. We are doing our best to minimize the impact of these potential budget cuts.

The vote taken on September 17 will BIND both towns to a budget figure for FY09. To ensure that those attending the meeting are fully informed, I'd like to let you know of some of the proposals you may hear during the intradistrict meeting, and the impact it will have on your tax rate and town services.

1. If both towns agreed to maintain the amount appropriate at town meeting last spring, that means a \$168,000 override for Gill. That would add approximately \$1.07 to the tax rate, or \$227 per year for the average homeowner. If the override failed at the polls, possible cuts to town services include:

a. Eliminate stipends for town boards and committees (moderator, select-

board, board of health, board of assessors.)

- b. Eliminate the position of animal control officer
- c. No cost of living increases for any town employees
- d. Defer the \$15,000 pump repair for the fire engine
- e. No funds to set aside for future increases in building inspector fees.
- f. Reduce town hall staff hours by 20%
- g. Reduce the police force by 0.6 of a full-time position
- h. Eliminate the part-time position of clerk for the board of health, zoning board of appeals, and planning board

2. If both towns agreed to fund the district at the level the Commissioner of Education has set (known as the "1/12 Budget"), that means a \$279,000 override for Gill. That would add approximately \$1.78 to the tax rate, or \$378 per year for the average homeowner. If the override failed at the polls, possible cuts to town services include what's listed in #1 plus:

- a. Reduce the police force by another 0.4 full-time position (eliminating one full-time officer)
- b. Reduce the highway department by 1 full-time position
- c. Close the Slate Memorial Library
- d. No funds for the council on aging, meaning no funds toward

the Gill-Montague Senior Center Director's position

e. No funds for the memorial committee, historical commission, or recreation commission

3. If both towns agreed to fully fund the school committee's budget request, that means a \$320,000 override for Gill. That would add approximately \$2.03 on the tax rate, or \$431 per year for the average homeowner. If the override failed at the polls, possible cuts to town services include what's listed in #1 and #2 plus:

a. Reduce the amount of highway department materials (asphalt, stone, sand, salt, etc.) purchased by 27%

Once again, THE VOTE TAKEN ON SEPTEMBER 17 WILL BIND BOTH TOWNS TO A BUDGET FIGURE FOR FY09.

If an override fails after the meeting, town services will be cut to allow for the town to pay the school assessment. The Selectboard urges ALL registered voters to attend the intradistrict meeting on September 17. Voters must make their intentions known that night. It is imperative that all who are able to attend do so. If you are currently not registered to vote, you may register with the Town Clerk by September 16 in order to vote on September 17.
