SELECTBOARD MEETING MINUTES June 17, 2013

Call to Order: The Selectboard meeting was called to order at 4:30pm.

<u>Present:</u> Ann Banash, Randy Crochier, and John Ward, Selectboard members; Ray Purington, Admin. Assistant; Janet Masucci, Claire Chang, and David Detmold.

Minutes: Ann made a motion, seconded by Randy, to accept the minutes from 6/3. The vote was unanimous in the affirmative.

<u>Town Hall Roof:</u> Ray reported that the roof replacement project is complete, but there are two punch list items to be dealt with. Additional sealant needs to be applied to a seam on the flashing on the front ledge of the building. Sealant is also needed to protect the bare wood in places where the clapboards were trimmed back to install the metal roof. He is working with RCI Roofing to resolve these issues.

Energy Audit: Bart Bales is scheduled to begin the energy audits at the Riverside Municipal Building, Library, and Town Hall with site visits on June 19th. The audit is a required precursor to any building improvements using the Green Community Grant, and is funded separately by an Owner's Agent Grant from Mass. DOER.

Sewer Commitment: Acting by consensus, the Board signed the June 18th sewer commitment in the amount of \$19,562.79. Ray reported that Tighe & Bond will be starting the initial phase of the Infiltration & Inflow study in the next week or two. The extra rainy June weather should provide elevated groundwater levels so that their field visit (opening and looking into manholes) will be informative.

Annual Appointments: The Board reviewed the list of annual appointments for FY14. Ann made a motion, seconded by Randy, to make the appointments as presented. The vote was unanimous in the affirmative.

<u>Cultural Council Appointment:</u> Ann made a motion, seconded by Randy, to appoint Marilynn Stowe Tomb to the Cultural Council for a term through 6/30/16. The vote was unanimous in the affirmative.

FRTA Representative: The Board reviewed a letter from the FRTA requesting the Town appoint a representative to the FRTA Advisory Board. Jim Poulsen has been the Town's representative, but is no longer interested in the position as the FRTA no longer provides a bus route to serve the NMH campus. In the annual appointments (above), Ray was appointed as a "designee" representative, and unless or until someone else is named, John as Selectboard Chair will be the Advisory Board member for Gill.

There was discussion about the FRTA's assessments to towns in Franklin County and beyond, and it was requested that a letter be sent to the FRTA asking for an explanation about how those assessments are determined. There are some towns with a \$0 assessment, while Gill's is \$6,151 even though there are no bus stops in town. If the assessment is simply to provide residents the right to access on-demand transportation services, then the FRTA should be able to provide a report on the frequency of use in Gill.

Highway Truck Debt Exclusion: The Board discussed the next steps for the new highway truck that was approved at Town Meeting contingent upon passage of a debt exclusion ballot question. September 10th was identified as a likely date for the vote, and Ray will check with the Town Clerk to confirm it as a good date. He will also prepare the wording of the ballot question and have it reviewed by DOR. It is expected that the election warrant will be ready for the Board to sign on July 1st.

<u>Highway Purchase Orders:</u> Three purchase orders for the Highway Department were reviewed. The Board approved a \$1,500 expense for broom heads for the sweeper and a \$4,800 expense for 6-8 catch basins used for road drainage projects. Citing a lack of specific information, a \$1,200 purchase order for traffic signs was not approved.

There was a brief discussion about signage at and around the intersection of Main and West Gill Roads, as there have been several accidents and near misses from vehicles failing to obey the stop sign before turning from West Gill onto Main. A larger stop sign is in the works, but needs an additional mounting pole. Other ideas were to paint warnings on the road, and to add a warning sign to the southbound lane of Main Road ahead of the intersection. The ideas will be passed on to the Highway Superintendent.

<u>Chapter 61B Right of First Refusal:</u> Ray informed the Board that Elsa Yarmac has given notice that she intends to sell her property at 91 Main Road. The land is in the Chapter 61B program, which gives the Town a Right of First Refusal in which it can match a bona fide offer to buy the property. Other Town committees have been notified, and have been asked to provide their input, if any, before the Selectboard's meeting on July 15th. At the buyer's request, the Town is attempting to expedite this process, which legally can take up to 120 days.

<u>Community Shared Solar:</u> Claire Chang and Janet Masucci were joined by fellow Energy Commission members Tupper Brown and Pam Lester. Claire provided an update the Board on recent information about Community Shared Solar.

Claire spoke about a conference call with Worth Robbins, the coordinator for the Harvard Community Solar Garden project in Harvard, Mass. It is a project that began in 2011 with the receipt of a US Treasury grant to cover a 500 kW solar array. The total grant is roughly valued at \$825,000 - 30% of 500,000 watts at 5.50 per watt.

The Harvard project is moving forward with a 250 kW array, and there is a possibility that the unused 250 kW from the grant might be transferable to another entity. This might be a way to partially fund a solar development on the Mariamante property, although time is running out on the expiration of grant. As the grant is a form of tax credits, the receiving entity could not be the Town. A private partnership or LLC are possibilities, and it is unknown if there would be a way for the Town to be a part of such an entity. Also, it is expected that there will be multiple groups interested in receiving the grant transfer.

The Harvard project has been a learning experience every step of the way. Many of the snags and roadblocks they encountered and worked through will help smooth the way (and speed the process) for similar projects in the future. In that project, an LLC was formed, and the installation is on privately owned land. The LLC has a 20-year lease with the landowner, with a lease payment of 3% of the annual output of the array. There are 40 subscribers to purchase the LLC's electricity, and 33 of them paid up front to buy into the program.

Claire noted that there are many steps to the process, including interconnection plans with WMECO, building permits, and a solar overlay site plan review by the ZBA, just to name a few. Also, if Gill wants to move forward with this, it is time to bring the Native American Tribes into the conversation.

There was a lengthy discussion about the need for many of the people present to contact the State Ethics Commission before any kind of project moves forward, and before any individuals start to work on it. It was noted that Claire and John are owners of the Solar Store of Greenfield, and that Tupper is a member of the ZBA. Additionally, Ray is an employee of the Town (which would be involved in any permit applications for the Mariamante property), and as a private citizen is also a member of the ZBA. Those considering involvement with any type of community solar project were urged to contact Ethics.

Tupper noted that he is excited about the project and its potential, and offered to spend a great deal of time to help make it happen. However, before committing to the endeavor, he sought assurances that there is support for the initiative. The members of the Selectboard made a general and cautious show of enthusiastic interest for the idea/project, based on what has been discussed tonight. It was reiterated that individuals need to contact Ethics first.

The Community Shared Solar discussion ended at 6:05 PM. David Detmold and the members of the Energy Commission left the meeting.
