



Dear Gill Board of Selectmen:

The purpose of this letter is to request your approval for me to hold more than one appointed position with the Town.

In general, the conflict-of-interest law restricts municipal employees from holding more than one appointed town position, where at least one position is paid. However, in recognition of the difficulty small towns experience in finding people willing to serve in town positions, the law gives Boards of Selectmen the power to grant exemptions from that restriction.

The multiple appointed positions I wish to hold are:

- 1) Administrative Clerk, 17 hours per week at \$20.69 per hour; and
- 2) Videographer, \$20 per hour, hours vary depending on length of meetings.

Under § 20 of the conflict-of-interest law, G.L. c. 268A, in towns with a population of less than 3,500, the Board of Selectmen may allow a municipal employee to have more than one appointed position. Since our town has a population of 1,551 according to Massachusetts Census Data, you as the Board of Selectmen have the power to authorize me to hold all the positions listed above.

I hereby request that the Board of Selectmen approve the exemption under § 20 to allow me to hold all the listed appointed positions.

### Flag Policy

### I. Introduction

This Policy is intended to address flags allowed to be flown on flagpoles owned by the Town of Gill. The Gill-Montague Regional School District shall determine the policy for flags that can be flown on flagpoles located at the Gill Elementary School.

### II. Flags Allowed to Be Flown

The Selectboard authorizes the following flags to be flown on Town-owned flagpoles, as an official expression of the Town's governmental speech, to which the strictures of the First Amendment do not apply:

The official flag of the United States of America;

The official flag of the Commonwealth of Massachusetts;

The official flag of the Town of Gill;

The official flags of the various branches of military services of the United States of America; and/or

The official MIA-POW flag.

No other flags shall be allowed to be flown on Town-owned flagpoles, as those flagpoles and this policy are not intended to establish or serve to create a forum for private expression.

Re: MBI Broadband Infrastructure Gap Networks Grant Program

To whom it may concern,

The Commonwealth of Massachusetts through its Capital Projects Fund has established the Broadband Infrastructure Gap Networks Grant Program. This program will fund broadband to unserved areas and the Town of Gill is very happy to hear that Comcast is planning to submit an application.

Comcast is an extremely valuable company and partner within the Town of Gill, which relies heavily upon Comcast's infrastructure. They have continually invested in their network providing a fast, secure and reliable product that can meet the growing business and residential needs.

Comcast services proved critical during the COVID pandemic. Most of our community was able to successfully transition to remote learning and working by utilizing Comcast's broadband network. However, there remain nearly a dozen homes without any access to broadband, and another dozen locations where distance and other logistical factors make the cost to extend Comcast's infrastructure prohibitively and astronomically expensive. Broadband continues to be integral to our community's needs and Comcast is the logical company to provide the "last mile" connections.

The Town also feels it is important to remind the team at MBI that Comcast did not receive any MBI grant funds in 2016-2018 for broadband expansion in Gill. The expansion that took place, amounting to 63 newly served addresses and an increase in Gill's "percent served" from 85% to 96%, was completely funded by a sacrifice the Town made while negotiating its last Comcast cable license renewal in 2016. In exchange for buildout, the Town dropped its PEG Access revenue percentage from 4% to 2.5% for the first nine years of the ten year license. We hope our turn for MBI-funded buildout has come at last.

We enthusiastically support Comcast's Broadband Infrastructure Gap Networks Grant Program application and recommend they receive the full funding needed to connect unserved residents and businesses within the Town of Gill.
